



## **OPENGRASS ARTS & MUSIC CAMP**

**MAY 13<sup>th</sup>, 14<sup>th</sup> and 15<sup>th</sup> 2011**

**Full Moon Ranch in Berryville Virginia**

### **Performer Commitment**

This is a commitment from the part of the signing Artists to participate in the Opengrass Arts and Music Camp at the Full Moon Ranch in Berryville Va. In any or all of the event dates (May 13<sup>th</sup>, 14<sup>th</sup> and 15<sup>th</sup>, 2011)

The Artists will create their own campground, consisting of a stage or staging area, provide sound, instruments and lights and a power source (Generator or other).

Ideally a campground should also have Artists works in it of any kind including but not limited to paintings, sculptures, graphics, audio-visual art, projections, dancers, hula hoopers, and any other kind of artistic expression that will compliment their performance.

Bands/musicians will be able to perform at their will at anytime between 11am and 11pm.

After 11pm performances can only be done with acoustic instruments and without the aid of any P.A. System due to noise ordinance in Clarke County. Drum Circles and acoustic Jams around campfires are suggested.

To help a little with the expenses of creating a campground and traveling to Berryville, Open Grass Inc. can provide bands and performers tickets for sale in consignment and split the profits (50% each party). Each ticket has a nominal price of \$40. Bands can sell tickets up to May 9<sup>th</sup>, 2011. The final sales report is due on May 10<sup>th</sup> with 50% of the sales proceeds and / or remaining unsold tickets.

Artists will choose the amounts of tickets they request based on a calculation of projected sales (we limit 50 tickets per request, but if you sell out your tickets you can re-order as many times as you desire). A check for 50% of the nominal price of the ticket (\$20) x number of tickets requested should be included with the request for tickets. This check will be kept as a deposit and not cashed. Instead it will be exchange for 50% of the sales proceeds plus the unsold portion of tickets provided (if any). If the artist fails to provide the final sales report with 50% proceeds of tickets sales and/or unsold tickets, then the check will be deposit in our corporate account on May 12<sup>th</sup>, 2011.

*\*\*\*Example\*\*\*:*

*Artists request 50 tickets (@ \$40 per ticket) Total value: \$2000.00*

*Artists should provide a check for \$1000 made to OPEN GRASS INC dated May 12<sup>th</sup>, 2011 along with their request for tickets.*

*Artists only sell 40 tickets (@ \$40 each) = \$1600.00*

*Artists should return the unsold tickets (10 tickets) with \$800 cash or money order (50% of sales proceeds) to OPEN GRASS INC. in exchange for their \$1,000 deposit check.*
