- Bring your own tables, tents, chairs, lights, Extension electrical cords and power strips, etc. Sorry, these are not provided . If you will need electricity (food vendors) you are required to bring a small generator.
- Spaces are assigned in order of receipt of application and fee.
- You will be guided to your space by a member of our staff.
- You should bring small generators or battery operated lights
- Vendors must be COMPLETELY set up and operational by 2 pm Friday May 13th.
- Vendors must clean site before leaving or by 9 PM on Sunday night.
- Bring picture ID (name on ID must match our welcome list)
- Farmer, Crafter and Artist's Entry entitle you to only 1 pass
- Non-Profits or informational booth require approval of Open Grass
- \$300 Food Vendor fee entitles you to 4 passes (main vendor and 3 helpers to run concession)
- All Participating vendors agree to advertise our event in their websites and display our fliers in all events they participate prior to May 13th, 2011
- Applications sent with the wrong fee will be automatically declined; please read instructions carefully or contact us.
 - Primitive camping allowed next to tent

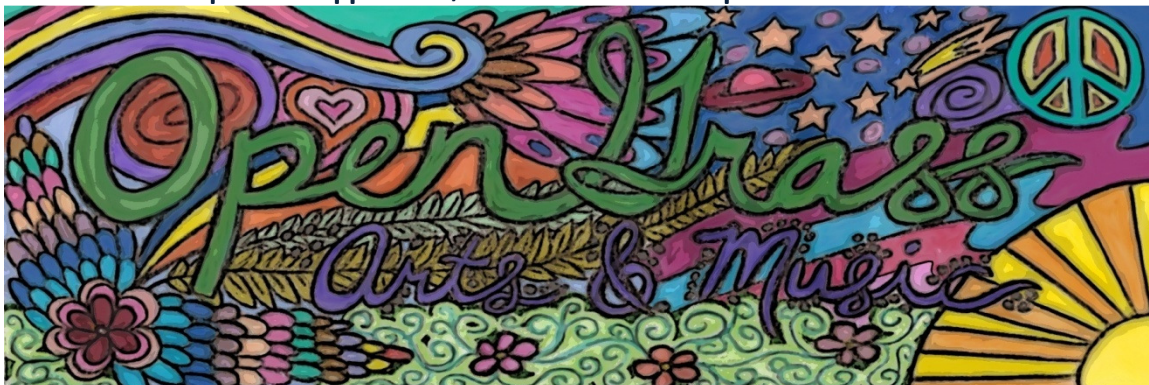
